KENNISGEWING geskied hiermee kragtens die bepalings van artikel 24 van die Wet op Plaaslike Regering : Munisipale Finansiële Bestuur, 2003 (Wet 56/2003) en Artikel 75A van die Wet op Plaaslike Regering : Munisipale Stelsels, 2000 (Wet 32/2000) dat die Kapitaal- en Bedryfsbegroting vir die 2021/2022-boekjaar op 25 Mei 2021 deur die Raad goedgekeur is en dat:

1. 'n Opsomming van die begroting vir die 2021/2022-boekjaar gedurende normale kantoorure ter inligting lê by die ondergetekende, sowel as alle biblioteke binne die Bergvliet Municipaliteit se regsgebied.
2. 'n Algemene eiendomsbelastingtarief van 0,01046 c/R met ingang van 1 Julie 2021 deur die Raad vasgestel word vir alle eiendomme behalwe die wat as Landbou, Industrieel en vir Kommersiële gebruik in die Waardasierol 2017 voorkom.
3. 'n Eiendomsbelastingtarief vir Landbougebruik van 0,00262 c/R vasgestel word met ingang van 1 Julie 2021.
4. 'n Eiendomsbelastingtarief vir Industriële en Kommersiële gebruik van 0,01151 c/R vasgestel word met ingang van 1 Julie 2021.
5. Die Raad alle ander tariewe aangepas het waarvan die besonderhede in die tarieflys ter insae beskikbaar is.

Bogenoemde eiendomsbelastingtariewe en gelde tree in werking op 1 Julie 2021 en verbruikstariewe vanaf die lesing van meters vir die prosessering van die rekeninge vir Julie 2021.

2021/2022-FINANCIAL YEAR: ADOPTION OF CAPITAL AND OPERATING BUDGET AND THE DETERMINATION OF ASSESSMENT RATES TARIFF, USAGE CHARGES, TARIFFS AND FEES

NOTICE is hereby given in terms of Section 24 of the Municipal Finance Management Act, 2003 (Act 56/2003) and Section 75(A) of the Municipal Systems Act (Act 32 of 2000), that Council adopted the Capital and Operational Budget for the 2020/2021 financial year on 25 May 2021 and that:

1. A summary of the budget for the 2021/2022 financial year will be available at the undersigned during normal office hours, as well as all libraries within the Bergrivier Municipality's region.
2. Council determined an assessment rate tariff of 0,01046 c/R for general property rates from the 1st of July 2021 with the exception of properties classified as Agricultural, Industrial and Commercial use in the Valuation role of 2017.
3. An assessment rate tariff for Agricultural use of 0,00262 c/R is determined from the 1st of July 2021.
4. An assessment rate tariff for Industrial and Commercial use of 0,01151 c/R is determined from the 1st of July 2021.
5. The Council has adjusted all other tariffs and fees of which the details are available in the approved tariff list.

The above-mentioned assessment rate tariffs, usage charges and fees will become effective from the 1st of July 2021 and consumption tariffs from the meter readings being used for the processing of the July 2021 accounts.
