The Executive Mayor requested that changes be made to the Indigent Policy which states that any person that receives a pension or disability grant from SASSA, automatically qualifies as indigent and that the information from family/people living in the same house is not required for approval as stated in the amended approved Indigent policy. That an implementation plan be submitted to the office of the Executive Mayor for the spending of the available funds for the Redelinghuys Plaas/Buurtweg before end of July 2022.

The Manager: Budget and Financial Statements gave a brief explanation of the changes that were made in the budget and inform Council that the comments received from the public has been taken into consideration.

Councillor Adams and Alderman Manuel congratulated the Executive Mayor and the Executive Deputy Mayor for the successful completion of the budget and thanked them for the work that has been done.

The Speaker thanked all Councillors, personnel and the public for their part in completing the budget.
