

### SUPPLY CHAIN MANAGEMENT IMPLEMENTATION REPORT FOR FEBRUARY 2024

1. In terms of Chapter 1 – paragraph 6(4) of the Councils Supply Chain Management Policy: "The Accounting Officer must within 10 days of the end of each quarter, submit a report on the implementation of this policy to the Executive Mayor." Paragraph 6(5) further states that: "The aforesaid reports must be made public in accordance with section 21A of the Municipal Systems Act."

#### 2. STATISTICAL INFORMATION:

2.1 DEMAND MANAGEMENT – The SCM Unit, with the support of the Chief Financial Officer has submitted a list to all Directorates that requires timely planning and management processes to ensure that all goods and services which are required are quantified, budgeted, and delivered in a timely manner at critical delivery dates, so that the budget can be dealt with as per the cash flow statements.

This Demand Management Plan will be used as a strategic tool to implement the budget. The Demand Management Plan will assist the SCM Unit and user departments with the planning of the execution and timely completion of projects in alignment with the performance targets in the Service Delivery and Budget Implementation Plan.

The new Procurement plan was distributed to all departments, and they needed to submit their specifications early as indicated in the procurement plan. Each Department will report on their own procurement dates and processes monthly and at the end of each quarter the Finance Department will report overall on all departments.

The legislation on procurement has changed as has been Gazette in Government Gazette 49863 on 14 December 2023.

# 10. PROGRESS REPORT ON IMPLEMENTATION OF THE MUNICIPAL STORES:

### 10.1. Health & Safety

Orelia Turner and Henco Van Wyk were nominated and appointed as the Health & Safety Representatives for the Piketberg Municipal Stores. The formal appointment was signed and sent to the Health and Safety Officer.

### 10.2. Observations:

- Lack of Safety signage Evacuation Route / Emergency Exit Signs needs to be added.
- No evacuation plan / procedure in place.
- Assembly points need to be allocated and signs need to be erected.
- Fire extinguishers need to be installed and signage to be added.
- No Fire fighter or First aider for department.
- No First aid box present.
- Spill kit to be acquired and designated area to be allocated; and
- Designated smoking area to be allocated, marked and regulation and signage to be added.

This was taken up with the relevant officials.

# 10.3. Fuel Bowsers:

- A Fuel Bowser checklist has been created and is in-line with industry standards.
- Demarked area to be marked for fuel bowsers for each of the respected municipal stores.
- Standard Operating Procedure for Bowsers is in the process of being created that will specify the issuing of bowser to electrical, refueling of bowser and general care & maintenance of bowser.

# 10.4. Stock Take Progress:

- The stock on the system that has item numbers has been verified with the current stock on hand.
- Electrical meters have been verified with the list provided by Henco/ Johannes and found that meters were already issued, and meters were recorded that have not yet been recorded.
- There are currently more meters than Keypads each meter that does not have an integrated keypad should be accompanied by an external keypad.

### 10.5. General:

• Standby schedule and Call-out procedure should be established.

- Access to stores has been limited to only staff Clearing of Gate motor code still needs to be done.
- Electrical has started taking/moving some of the boxes at the back, a plan for removal of other parts and scrap will still need to be discussed with supervisor/superintendent.
- Vehicles are being parked on the premises after hours with no prior authorization.
- Portable Toilets are still parked at the Municipal Stores in Piketberg. Various requests have been issued to the technical department to remove the Portable Toilets.
- Electrical wire rolls are to be put on a stand design and functionality thereof to be discussed and implemented.
- Various items that still need to be removed for the premises (Demonstration vehicle from traffic etc.).
- The replenishment of stock items that have item numbers needs to be established and formulated.

# 11. RECOMMENDATIONS
