NOTICE OF PUBLIC PARTICIPATION PROCESS FOR INTERESTED AND AFFECTED PARTIES AND AUTHORITIES: REVIEW OF THE WESTERN CAPE AIR QUALITY MANAGEMENT PLAN

The Western Cape Government, through the Department of Environmental Affairs and Development Planning (DEA&DP), both implements systems and provides an oversight role in the Province with respect to air guality management. In line with the National Environmental Management: Air Quality Act (No. 39 of 2004), a Western Cape Air Quality Management Plan (AQMP) was developed in 2010 to manage air quality in the Province

Following 5 years of its implementation, the DEA&DP embarked on a review of the Western Cape AQMP. During 16-22 September 2015, the DEA&DP conducted the first round of Public Participation Process Workshops for Interested and Affected Parties (I&APs), as well as authorities in the different regions of the Province to, inter alia:

- assess progress made in air guality management in the Province;
- establish whether the identified goals and targets have been effectively implemented;
- · establish whether the goals and targets were still valid in terms of new developments and economic growth in the Province: and
- identify potential air quality risks and interventions that can be translated into new goals and objectives. where required.
