ADDENDUM NO. 1:

Bidders must kindly note the following:

- The retention guarantee of 5% (referred to on page 11) must be secured and 1. submitted within 7 days after appointment. Bidders must make provision for this in their pricing.
- The performance guarantee (referred to on page 11) must be secured and submitted 2. within 7 days after appointment. Bidders must make provision for this in their pricing.

The completion date must be within 4 weeks and bidders must provide for this 3. in their pricing.

- Additional technical specifications: 4.
 - PVC kick plates in black, clip-on, with adjustable foot-pieces, and with approximate dimensions between 120mm - 150mm
 - Drawer runners; telescopic ball bearings, consistent with the depth of the drawers
 - Hinges; normal straight
 - Formica Top; gloss
 - Backing for cupboards; white hardboard
 - Cupboards colour; maple
 - Carcasses; white melamine
 - Impact edging; 2mm to match colour of the cupboards (maple)
 - Handles; bar type, 100mm
 - Top cupboards; ±320mm deep
 - Floor unit carcasses; ±550mm
 - Overhang of counter top; ±50mm .
 - Height of floor cupboard = ± 770 mm (excluding the kick plate) .
 - Final height of floor cupboards must be between 900 920mm (including kick plate, . which must be adjusted accordingly)
