CA welcomed all present and gave a short background regarding the purpose of the clarification meeting.

CA started by mentioning that the tender will close on 2 July 2024 and only service providers present at the clarification meeting is entitled to submit a bid.

He emphasised that no faxed or emailed bid will be accepted. Tenders in hard copy format must be placed in the tender box at the Municipal Building in Kerk street, Piketberg.

Tender amounts must include vat (Value Added Tax).

CA went briefly through the tender document regarding the supply chain matters.

Tender Specifications

CA went through the specifications and address any uncertainties.

On the top of page 45 it states clearly that AARTO fees will only be negotiated once AARTO is implemented.

Decision was taken that no pricing will be submitted for AARTO offences.

4.3.2.1 30 September2024 changed to 31 October 2024 due to the fact that the tender running later.

Road Block Support Vehicle – proof of registration must be submitted with tender.

4.3.7.2 *correction of 2 fixed camera systems and not* **3**
