## ADDENDUM NO. 1:

Pursuant to the compulsory clarification meeting held on Wednesday, 11 November 2020, bidders must kindly note the following;

- the hall does not form part of this FQ.
- the storeroom on the northern side does not form part of this FQ.
- the skirtings must be sanded and varnished with two coats of dark oak.
- 2 coats of paint are required, with a washable and durable paint (Plascon, Dulux or similar in quality).
- the floor of the toilets on the western side must be painted with an epoxy-based paint, which is water-resistant, anti-skid, scratch-resistant, flexible and color-fast.
- the corridor in the northern section must be made good by skimming with a suitable crete-stone.
- the exterior of the building must be included.
- the cracks in the cloakroom walls at the two door-frames must be repaired and made smooth.
