## 2. STATISTICAL INFORMATION:

**2.1 DEMAND MANAGEMENT** – The SCM Unit, with the support of the Chief Financial Officer has submitted a list to all Directorates that requires timely planning and management processes to ensure that all goods and services which are required are quantified, budgeted, and delivered in a timely manner at critical delivery dates, so that the budget can be dealt with as per the cash flow statements.

### 3. MONTHLY REPORT ON DEVIATIONS AND MINOR BREACHES

The Municipal Supply Chain Management Regulations - Gazette 27636 0f 30 May 2005, states in Section 36 "

(1) A supply chain management policy may allow the accounting officer-

- a) To dispense with the official procurement process established by the policy and to procure any required goods or services through any convenient process, which may include direct negotiations, but only
  - i. In an emergency
  - ii. If such goods or services are produced or available from a single provider only.
  - iii. For acquisition of special works of art or historical objects where specifications are difficult to compile.
  - iv. acquisition of animals for zoos; or
  - v. in any other exceptional case where it is impractical or impossible to follow the official procurement process; and
- (b) To ratify minor breaches of the procurement process by an official or committee acting in terms of delegated powers or duties which are purely of technical nature.
- (2) The accounting officer must record the reasons for any deviations in terms of sub regulation (1) (a) and (b) and report them to the next meeting of the council, or board of directors in the case of a municipal entity and include as a note to the annual financial statements.

For the month of February 2023 there was one deviations for an emergency acquisition of generators, one for impractical for the relocation of the new Director and one deviation for cable theft.

### 4. **DISPOSAL**

The system of disposal management must ensure the following: -

- Immovable property is sold only at market related prices except when the public interest or the plight of a poor demand otherwise,
- Movable assets are sold either by way of written quotations, a competitive bidding process, auction or at market related prices, whichever is the most advantageous,

- The asset verification committee was established, and part of the Committee are the following members, Hendri van Niekerk, Urlston van Wyk, Terry-Anne Wessels and Cavin Cornelissen. The final meeting for disposal will be on 22 March 2023.

The BEC, appointed by the Municipal Manager on the 3<sup>rd</sup> of February 2023 consisted of the following officials: Ms. ER Scholtz (Accountant SCM), Mr. J Breunissen (Manager Technical Services), Mr. W Burger (Civil Technician), Ms. R Hendricks (Administrator SCM). Tenders were checked for both completeness and responsiveness. The bid evaluation committee was held on Monday 06 February 2023.

### 3.3 FUNCTIONALITY EVALUATION

All the tenders were evaluated based on the functionality criteria prior to undertaking the financial evaluation of the tender. The technical proposal was evaluated as a prerequisite where the minimum total functionality score required was 70% as specified in the tender document. Each tenderer was evaluated based on the following criteria category:

- Specialist expertise and previous experience with work of a similar nature. To be substantiated by submission of a detailed list and description of relevant projects/work.
- Submission and quality of CVs of staff to be employed on the contract showing expertise and experience with work of a similar nature.

### 3.5 TENDER /DISCUSSION

Futi Construction allowed for a **2mm thick HDPE liner instead of the prescribed 3mm thick HDPE liner**. This is not acceptable and is a deviation from the prescribed specifications. They also indicated the utilization of subcontracting but did not indicate the percentage of work which will be performed by the subcontractor. **Futi Constructions tender is considered as non-responsive.**

The bank code of Westland Construction is acceptable.

The bank code of Futi Construction is for a short period and a very low amount. This is a major risk to the Client and could have cashflow complications during the construction period.

Lwazi Construction submitted a letter with their tender stating that an external company will provide them finance with a value of R 3 000 000-00. This may also be a risk to the Client.

#### 3.6 Local Content

In terms of returnable schedule MBD 6.2, the tender stipulated the requirements pertaining to the following declaration for local production and content: Westland Construction and Lwazi Construction complied to the minimum requirements for local content goods. Futi Construction did not comply with the minimum requirements for HDPE pipes and are therefore considered non-responsive.
