1.2	<ul style="list-style-type: none"><li>Response time (page 47): <b>The service provider must respond within 30 minutes.</b></li><li>The response team is comprised of a:<ul style="list-style-type: none"><li><b>Tactical team comprising of no less than 5 guards, fully uniformed, equipped with the necessary resources.</b></li></ul></li></ul>
1.3	<ul style="list-style-type: none"><li>Break down team (Driver + Truck + Break down staff – a minimum of 5 to be deployed at any given time)</li><li>Rates have been inserted in the pricing schedule to allow for mobilization of suitable resources:</li><li>Service providers will be required to fully assess the need and consult with the municipality before deploying resources.</li><li>Rates inserted to allow for removal of pegs.
