The Quotation price must be VAT inclusive.

Bidders must be registered as a prospective supplier on National Treasury's Database CSD (Central Supplier Database).

Quotations will be valid for a period of 90 days from the closing date.

A valid original tax clearance certificate issued by the South African Revenue Service (SARS) must be included with the bids.

Quotations must be accompanied by a valid BBBEE verification certificate or a certified copy thereof.

Only quotations completed in **black** ink on the original quotation documentation will be accepted. Late, incomplete or quotations submitted by facsimile or email will not be accepted. Proof of submitting a quotation will not be accepted as proof of the quotation having been received. The Municipality is not obliged to accept the lowest or any quotation submitted to it. The Municipality reserves the right to accept any quotation in full or in part.
